If a student's complaint received by the Anti-Ragging Committee, the complaint is dealt with properly and legally. But in the academic year 2020-21 no students complaints have been registered in the Anti-Ragging Committee.

Ragging is totally prohibited in the Shivaji University and all affiliated colleges & institutions and anyone found guilty of ragging and abetting ragging, whether actively or passively, or being a part of a conspiracy to promote ragging, is liable to be punished in accordance with these regulations as well as under the provision of any penal low of the time being in force.

Objectives -

Ragging constitutes one or more of any of the following acts:

- 1) Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
- 2) Indulging in rowdy or indisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other students.

- 3) Asking any students to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of same or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any after student.
- 4) Any act by senior student that prevents, disrupts or disturbs the regular academic activity of any after student or a fresher.
- 5) Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- 6) Any act of financial extortion or forceful expenditure burden put on a fresher or any other students.
- 7) Any act physical abuse including all variants of it sexual abuse homosexual assaults, stripping, forcing obscene and lewd acts gestures causing bodily harm or any other danger to health.




